## Mater Dei High School

### Waiver and Release Regarding COVID-19 for Households with Frontline Workers

I am the parent or legally authorized guardian of the child participating in a summer athletic camp at Mater Dei High School (the "School"). On behalf of myself, my spouse, my child/ward (the "Participant"), and my/our heirs, personal representatives, and assigns, and in consideration for Participant being allowed to take part in the summer athletic camp, I make the following representations. If I am the Participant and 18 years of age or older, I make these representations for myself.

One or more members of the Participant's household is a frontline worker such as a first responder or a healthcare worker who, by the nature of their occupation, come into contact with individuals who either have the COVID-19 virus or may have been exposed to it.

In order to access the Mater Dei campus and facilities, I confirm the following:

1. Neither I nor any member of my household are diagnosed with or currently ordered quarantined due to the COVID-19 virus, nor do I or any member of my household have (or have experienced within the last 15 days) any of the common symptoms associated with COVID-19 including fatigue, coughing, respiratory distress, or fever.
2. With regard to the member(s) of my household who are frontline workers and who have come into contact with individuals who either have the COVID-19 virus or may have been exposed to it, I certify and warrant that such frontline workers strictly abide by all health agency directives regarding mitigating the spread of the COVID-19 virus, use personal protective equipment, and are regularly tested for the COVID-19 virus.
3. I have adequate health insurance for my family and for myself.

If, at any time, I learn that any of the above is no longer true, I will immediately notify School staff and cease Participant's participation in the summer athletic camp, including coming onto campus. In addition, I will notify the School and provide it with a release from a healthcare provider which states that Participant is safe to use campus facilities. If I cannot do so, I understand that Participant cannot come onto campus or participate in the summer athletic camp. In addition and in recognition that I have one or more household members who are frontline workers, I understand and agree that Participant may be subject to additional precautions including, but not limited to, temperature checks and health screenings in order to access the Mater Dei campus and facilities.

I understand the School expects Participant to, while on campus:

1. Wash hands with soap and water for at least 20 seconds or, if washing hands is not feasible, to use alcohol-based hand rub or sanitizing wipes prior to entering or upon re-entering the campus and frequently while on campus.
2. Maintain at least six feet of personal space between Participant and others.
3. Wear face masks at all times, except when participating in athletic camp activities.
4. Follow all other recommendations/requirements of health and government officials to prevent the spread of COVID-19.

I understand that these precautions and my representations above are vital and necessary to maintain the safety of School students, staff, other camp participants, and volunteers.

While the School is taking precautions to prevent the spread of COVID-19 on campus, I understand that Participant's involvement in summer camp athletic activities at the School and using its facilities will necessarily increase the risk that Participant could contract COVID-19. This means Participant and Participant's family and others coming into contact with Participant could suffer damages caused by COVID-19 which can be extremely severe and include respiratory distress, organ damage, coma, and death. I agree and understand that participation in the School summer athletic camp activities is entirely voluntary. Knowing these risks, I, on behalf of Participant, nonetheless knowingly agree to assume these risks. I understand that if I or Participant have questions about possible COVID-19 hazards, it is our responsibilities to seek additional information from School staff prior to signing this Agreement.

I hereby release, waive, discharge, hold harmless, indemnify, and defend the School and the Catholic Diocese of Orange, as well as their respective employees, staff, volunteers, agents, and representatives, from any and all liability, losses, damages, claims, actions, attorney's fees, and causes of action of every nature, whether claimed by Participant, myself, my family and assigns, or any third party, for any and all known or unknown, foreseen or unforeseen, bodily or personal injuries, property damage, or any other loss or damages relating in any way to Participant's participation in the School summer athletic camp, including associated travel.

I agree to comply with all additional rules adopted by the School regarding the use of the facilities and equipment.
