Entries: Entries per individual shall be according to rule 3-2-1. Each school shall be permitted a

maximum of 3 entries in an individual event with the exception of the 50 Freestyle and 100 Freestyle. The 50 Freestyle may have 3 additional entries and 100 Freestyle may have 2 additional entries, additional swimmers (more than 3) in the 50 Freestyle and 100 Freestyle will be entered as "Exhibition". Each school shall be permitted a maximum of $\underline{2}$ teams per relay event with the exception of the 200 Freestyle Relay which may have 1 additional entry, only $\underline{1}$ relay team may score team points and receive medals from each school. By Rule 3-2-1: A competitor shall be permitted to enter a maximum of four events, no more than two of which may be individual events. An exhibition swim shall count as one of the four allowed entries,

does not score points, but may count as a qualifying time.

Meet Entry: All entries will only be accepted from Hy-Tek's Team Manager. Don't forget to enter a "Best

Time". Once you have completed your entries, email the file to ewolgast@usd266.com. I would recommend that you email these early so that we can identify any problems you might be experiencing a.s.a.p. If you send me entries several days prior, but choose to make changes, send me your entire entry file. I will just overwrite your previous entry file with your new one. Changes can be made anytime all the way up to the deadline. Entry deadline is December 4 at 12:00 pm. It is recommended that coaches bring a backup of their entries on flash drive so any changes might be uploaded that morning. Results will be available at the conclusion of the meet
