### Pre-Season Athlete-Parent-Coach Agreement



#### Athlete Agreement





### Parent/Guardian Agreement

### Uniform / Equipment Care Agreement

  - b. You paying the cost to replace the damaged / lost item to the team if the loss / damage is determined to be a result of negligent actions or behavior.
